### Adult Undergraduate Guest Student Registration Agreement

This form is for individuals who want to enroll in undergraduate coursework and are not formally admitted to a WSU degree, licensure, or certificate program. High School Students and individuals intending to enroll in a formal WSU program must apply through the WSU Undergraduate Admissions office.

**Undergraduate Guest Student Status** is only valid for one term. Individuals must re-apply each term. *Guest Student* registration is on a space available basis only. *Guest Students* are responsible for all WSU deadlines, policies, and procedures published in the WSU online catalog, and are responsible for all tuition and fees associated with their registration. Failure to attend class does not constitute a valid drop, withdrawal, or cause for refund. *Guest Student* status is not an alternative to the official WSU admission process. *Guest Students* who intend to apply for formal admission to WSU may only use a maximum of 12 earned guest credits towards their WSU bachelor's degree. All students enrolling in courses requiring pre-requisites must provide the appropriate documentation (e.g., transcript). **MnSCU Visiting Students should not use this form.** You are a *Visiting Student* if you are formally admitted to another MnSCU system institution such as Southeast Tech, Metropolitan State, Bemidji State, etc. *Visiting Students* should use their home school online registration portal to register for WSU courses. *Visiting Students* must contact the Financial Aid office at their home school regarding consortium agreements and financial aid eligibility. Financial aid from WSU is only available to students formally admitted to a WSU approved program.
