- a. To gain a greater understanding of the diversity of Western culture through the *in situ* study of the arts and culture of a specific Western country. Through this, students will develop a deep appreciation of the cultural heritage of the selected country, as well as its similarities and differences with regards to American culture.
- b. To increase the ability of students to learn about and adapt to a variety of universal languages. Examples: maps, body language, signs, graphics, symbols, images.
- c. To instill a greater appreciation in students of the importance of history, its continued influence, in Western nations whose art, culture and language frequently span thousands of years.
- d. To gain an insight into the great diversity in these countries, including with regards to regions, cuisine, language and dialect, customs, religion, educational opportunities, and the rural/urban divide [the course will visit both metropolitan, provincial, and rural areas].
- e. To understand the many ways in which history informs the contemporary forms of societies.
- f. To learn and gain an understanding of the basic history of the selected country.

2. A statement of how this course will contribute to the departmental curriculum.

This course will endow students with a broader, experiential understanding of art and its connections to culture within the visited country. The Art Department curriculum emphasizes both the history of Western art and art-making techniques which have deep histories in Western Europe. This travel study course will enable students to experience some of the greatest art of the Western tradition in person, enriching their knowledge and understanding of the traditions they work within.

2. A statement of why this course is to be offered at this level (i.e. 100-, 200-, 300-, 400-, or 500-level)

This course is offered at 300 level due to the intensity of the course load and assessment requirements, including creative projects and set readings. Students are expected to not only increase their artistic skill and knowledge, but also their skills in communication, presentations, and critical thinking/research. These demands, condensed into a short timeframe, make the 300 level designation appropriate.
