Maximum Student Credit Load for the Summer term is: Undergraduate Students: 19 credits; Graduate Students: 12 credits. Exceptions may be made by the appropriate College Dean or Director of Graduate Studies.

Withdrawal deadlines are set at 80% of the way through the course and **are posted online in course information**. Withdrawals are noted on the transcript by a **W** indicator.

Final Examinations are held during the last scheduled class meeting or as determined by instructor.

Summer 2017 Term Grades are due no later than 12:00 noon, Monday, August 14, 2017. However, faculty may choose to enter grades online for a completed course at any point during the summer term.
