#### **BEGIN APPLICATION**

......

Begin your application for "Advanced Practice Social Worker" licensure. You may begin the application up to six months prior to graduation. Apply online at https://license.wi.gov/

First-time applicants select "Social Worker- Advanced Practice" and "Licensure by Examination." Applications for licensure cost \$165. The WI Statues and Rules exam is also required for licensure and may charge an additional fee.



#### **UPLOAD SUPPORTING DOCUMENTS**

The application for licensure requires you to upload the following applicable documents: marriage/divorce certificate, any criminal convictions/pending charges, veteran request application addendum, any malpractice suits/claims, and WI Dept of VA voucher code.

Exam scores are added to your file by the respective third party later.\*



#### FINISH APPLICATION

Once your application is complete and you have paid the application fee, WI Dept of Safety and Professional Services (DSPS) will issue an application number and password, which you will use to complete the WI Statutes and Rules exam. They will also issue instructions to take the national ASWB exam.

Students should wait to take all exams until they have been given approval by WI DSPS.\*\*



### TAKE EXAMS

Register to take the national exam through ASWB using DSPS instructions. There is a \$230 exam fee paid directly to the ASWB. Once you know your exam date, show up and take the exam!\*\*

You will also take the WI Statues and Rules Exam, accessed at: https://dsps.wi.gov/Pages/Professions/SocialWorker/Exams.aspx

Use the applicant ID, exam name, and password issued to you by DSPS to complete the WI Statues and Rules exam.



#### SEND TRANSCRIPT

Wait until you have completed ALL degree requirements, contact the Registrar to submit your official transcript to your DSPS application.

ASWB will send you a letter when your application is fully approved.

You may apply to take the LICSW exam work practice, including at least 1,000 hours of face-to-face client contact and including DSM diagnosis and treatment of individuals. and be an APSW.
