

## Housing and Meal Plan Cancellation Policy for 2023-2024

<u>Submitting a Cancellation Request</u>: Since this is a legal Agreement between the student and Winona State University, all cancellations must be made by the student via their Housing Portal or emailing <u>housing@winona.edu</u>. *Requests made by anyone other than the student will be considered invalid and could delay processing*.

This cancellation policy applies to all students living in the WSU Residence Halls including: Alumni House, East Lake Apartments, Kirkland-Haake, Prentiss-Lucas, Sheehan, Morey-Shepard, Richards, Conway, and the Sustainability House.

Student cancels AFTER the Agreement start date of: August 17, 2023 for Fall 2023 / January 7, 2024 for Spring Only 2024	
Student cancels their agreement to move off campus while still remaining a student at Winona State University <b>OR</b> Student's conduct is such as to require removal from residence halls	<ul> <li>Incurs an \$800.00 Cancellation Fee</li> <li>Room and Meal Plan pro-rated</li> <li>Dining Dollars are non-refundable</li> </ul>
<ul> <li>Student graduates from Winona State University</li> <li>Student is affiliated with Winona State University programs that are away from campus (Internships, Student Teaching, Rochester Nursing Program, &amp; Study Away) and approved by department.</li> <li>Student is released from their residence hall during their term of agreement for: <ul> <li>a. Non-admission, official approved withdrawal, or dismissal from the University by academic suspension</li> <li>b. Experiences a serious medical or health problem requiring withdrawal</li> <li>c. Extreme, unanticipated financial hardship arising after the beginning of academic semester</li> <li>d. Marriage</li> <li>e.
