

TO GET STARTED

STEP 1

PLEASE APPLY FOR ENTRY TO WSU

winona.edu/admissions/undergraduate/apply.asp

STEP 2

CHOOSE THE ROCHESTER CAMPUS, NOT WINONA

This is very important because it indicates you are looking for the online completion program that is only offered through our Rochester campus.

STEP 3

CHOOSE THE "ON CAMPUS" OPTION

All classes are online, but this completion program is part of an on-campus major, so you must select this option.

STEP 4

CHOOSE THE ACCOUNTING CANDIDATE OPTION

STEP 5

SEND ALL TRANSCRIPTS TO WSU

STEP 6

WAIT FOR WSU TO CONTACT YOU
