

Awaiting WSU's signature on the NDA so that Data Governance can obtain and review Quests HECVAT report


Concern is that the NDA will not allow system-wide discussion but only WSU discussion

Potential Solution - our preliminary review of the NDA does not seem to specifically restrict discussion system-wide and if it does then we could ask Quest for a broader NDA amendments.

Awaiting Legal and Data Governance review of NDA and requesting changes if needed or signing.

Concern was raised regarding the request of a Quest provided label printer to be used on the network - information be transferred wirelessly for workflow purposes.

Resolved - Quest will provide a second printer so that information can be printed by direct connection at a near by location for both the clinic and the lab.





- Confidentiality & Privacy of Student Information
 - PyraMED is both HIPAA and FERPA compliant. Additionally, PyraMED supports industry standards for securing student records. For example, 2MFA (DUO) and SSO for user access, Citrix, and SSO for student access to the web portal.

Hardware

■ The current user machines are supported. No additional or secondary machines are necessary.

Backup & Recovery

• All databases are configured with point-in-time recovery. In addition, critical configuration and log files are multiplexed across separate devices. Image-based backups are run nightly on all servers/VMs, with daily incremental and full weekly backups being taken. All backups are stored in encrypted at-rest storage, utilize AES 256-bit encryption, and are immutable. Backups are replicated to our secondary data center facility daily utilizing a secure layer 2-gigabit point-to-point ethernet connection. Image-based backups are run nightly on all servers/VMs, with daily incremental and full weekly backups being taken. Proactive security monitoring and threat detection. The PyraMED network is protected using a Cisco virtual ASA firewall that is locked down on all necessary ports. The entire stack is built on redundancy. There is no single point of failure

Audits

• The System audits and patient audits are very thorough. Every change or modification a user makes is audited. Every change, modification or access to a patient record is audited and reportable.



POTENTIAL SFMC APPROVAL

Equates to an additional \$77,000.00 annually *(approximately \$8-9,000 per percentage increase) which would more than cover the investment in PyraMED (average 13,000/year)

(additional amount beyond that would help offset the counselor salary that is on health services' budget)

(additional amount for Sysmex analyzer in the lab approximately \$30,000.00) and other unforeseen needs until esserve is replenished.
